The Community Living Program serving 10 counties in Virginia. These programs include congregate, home delivered, and shelf stable meals, 8 active life style centers, 2 adult day health services centers providing respite care, in-home/personal care/companion/coordinated care services, Veteran-Directed Home and Community Based Services for veterans of all ages, Care Transitions Intervention designed to reduce hospital readmissions while improving health outcomes and lowering health care costs, fan care/air conditioners/safety net services, community action services for low-income families and youth, senior employment training, 1,573 volunteers, most of whom are enrolled in the Retired and Senior Volunteer Program (RSVP), and many other related activities.

Bay Transit provides public transportation for "all people of all ages". Serving 12 Virginia counties, we have provided 146,236 rides. 128,172 rides allowed residents to access employment, health care, and numerous other consumer services, 13,121 fixed route rides via in-town West Point, the Gloucester Courthouse Circulator, and the Rivah Ride in Tappahannock, 4,669 New Freedom Mobility Management rides for access to health services outside the service region and outside Bay Transit's normal hours of operation, and 274 personalized MedCarry rides for the very frail to access various treatments and therapies.

Bay Family Housing services 10 Virginia counties. Multi-Family Housing provides service enriched supports to 282 residents age 62 and older residing in 9 Bay Aging apartment communities located in the Middle Peninsula and Northern Neck. The Housing Choice Voucher Program allowed 405 people of all ages access to 163 safe, stable homes. Single-Family Housing encompasses 4 major initiatives - Weatherization, Indoor Plumbing Rehabilitation, Emergency Home Repair and Community Development Block Grants: 92 homes received significant energy efficiency upgrades and repairs to help 131 people live in more healthy, stable homes; 7 of those homes were substantially rehabilitated via Community Development Block Grant.
