

The Community Living Program offers a range of programs and services that benefit people of all ages. Serving more than 20,000 individuals in Fiscal 2018, these programs include congregate and home delivered meals; 8 active lifestyle centers (senior centers); 2 adult day care centers providing respite care; In-home personal care, companion care and coordinated care services; Veteran-Directed Care Financial Management Services and Counseling; Care Transitions Intervention designed to reduce hospital readmissions; Care Coordination serving Medicaid patients across Virginia; senior employment training and insurance counseling, information and referral services, and other activities. 1,399 volunteers provided 28,555 hours of service for meal deliveries, non-emergency medical rides,

Bay Transit provides public transportation for all people of all ages. Across our 12-county service area we provided 138,480 rides in Fiscal 2018. Riders utilized Bay Transit to access employment, healthcare, shopping, and numerous other consumer services. The New Freedom and Med-Carry programs served 577 people with more than 4,000 rides to critical healthcare service destinations beyond our standard service area.

Bay Aging Senior Apartments, which are HUD subsidized properties, provide safe, affordable housing and enriched supports to 317 occupants age 62 and older residing in 9 apartment communities located in the Middle Peninsula and Northern Neck. The Housing Choice Voucher Program allowed 371 people of all ages access to 153 safe, stable homes. Single-Family Housing encompasses 4 major initiatives - Weatherization, Indoor Plumbing Rehabilitation, Emergency Home Repair and Community Development Block Grants. These programs updated 89 homes, allowing 120 people to live in more healthy, stable homes.
