Bay Transit provides public transportation for all people of all ages. Across our 12-county service area we provided 143,106 rides in Fiscal 2019. Riders utilized Bay Transit to access employment, healthcare, shopping, and numerous other consumer services. The New Freedom and Med-Carry programs served 621 people with more than 4,800 rides to critical healthcare service destinations beyond our standard service area.

4c (Code:) (Expenses \$ 1,808,872 including grants of \$) (Revenue \$ 1,985,355)

Bay Aging Senior Apartments, which are HUD subsidized properties, provide safe, affordable housing and enriched supports to 366 occupants age 62 and older residing in 10 apartment communities located in the Middle Peninsula and Northern Neck. The Housing Choice Voucher Program allowed 570 people of all ages access to 272 safe, stable homes. Single-Family Housing encompasses 4 major initiatives - Weatherization, Indoor Plumbing Rehabilitation, Emergency Home Repair and Community Development Block Grants. These programs updated 145 homes, allowing 310 people to live in more healthy, stable homes.
